**Deadline: April 15, 2024**

### **Eligibility Guidelines:**

Applicants must be graduating seniors of a high school in Camden, Glynn, Liberty, or McIntosh County who plan to pursue post-secondary studies.

Applicants must have been accepted into an accredited college or vocational school. They must also provide proof of enrollment or acceptance. Proof may include a copy of their acceptance letter from the institution.

A Minimum GPA of 2.50 is required.

Applicants must provide two recommendation letters. All letters must be mailed to the address listed below. Sources may include school officials, high school teachers, instructors, community leaders, pastors, etc.

Only original work will be accepted.

Applications must be complete. Please write legibly in blue or black ink when completing the application.

**To be eligible, entries must be submitted as outlined.**

**Submission:**

Include a two-page, grammatically correct, double-spaced, typed essay in black, 12-point Times New Roman font with 1-inch margins on **one** of the following two topics. Your document should be between 300 and 500 words on standard 8.5 X 11 letter-sized paper.

***Option One-***

What is the most significant challenge facing your generation, and how do you think a college education can help you prepare for it?

***Option Two-***

What does community service mean to you?

Your completed application with all requested material must be given to a member of Amman Court #195 by April 15, 2024. Alternatively, you can mail the application, ensuring that it is postmarked by the close of business on April 15, 2024.
