

Tricia and Charlie Smith, Jr. Scholarship Fund 2024 Scholarship Application

The Tricia and Charlie Smith, Jr. Scholarship Fund was established to provide financial assistance to a Camden County High School senior pursuing a post-secondary degree in the medical field.

ELIGIBILITY CRITERIA:

1. Applicant must be a graduating senior of Camden County High School.
2. Applicant must have a minimum 3.0 GPA.
3. Applicant must accurately complete the application package.
4. Applicant must include 3 letters of recommendation. Recommendations should come from teacher, guidance counselor, church leader, mentor, or a prominent leader in your local community. We ask that this letter be typed, signed, and attached to this application. Recommendation letters should reflect detailed information as to why the student deserves this medical based scholarship.
5. Applicant must include a copy of the acceptance letter from a college, university, junior college, trade school or technical college, and must agree to pursue a degree in the medical field.

ESSAY TOPIC

Essay: Write an essay not to exceed 500 words and attach to your application. The essay must be typed Times New Roman, (12) font, 1-inch margins, and double-spaced on 8 1/2" x 11" paper.

Essay Topic: A 500-word essay explaining your plans for the future, your interest in the medical field, and why you should receive the Tricia and Charlie Smith, Jr. Scholarship.

DEADLINE TO APPLY

1. Application must be received by **April 12, 2024**.
2. Application received after April 12, 2024, will not be considered. If mailed, must be post marked April 10, 2024.

Scholarship recipients will be announced during the award ceremony at Camden County High School.

Upon proof of enrollment, scholarship awards are paid and mailed directly to the college or university. If scholarship recipient does not enroll in selected college, university, junior college, trade school or technical college, the scholarship will be null and void.

SCHOLARSHIP DURATION

This scholarship is awarded for a period of one academic year.
