The GEO Group, Inc., **FIPC** Academic Scholarship

The GEO Group, Inc., **Folkston ICE Processing Center** Academic Scholarship is presented each year to a senior member or members of the Camden County High School graduating class to be utilized for higher education. The Camden County High School Principal will distribute the scholarship forms to all interested senior class members for notification to apply for the scholarship.

The amount of The GEO Group, Inc., **FIPC scholarship** will be determined. This scholarship money is to be used for expenses strictly related to the college expense and will be awarded upon verification of enrollment and acceptance. This money will be paid to the recipient of the scholarship, in the full amount, at the beginning of the school year after the student is enrolled and attending the college or university during the first college year.

The school committee will vote for recipients for this scholarship. Alternates will also be selected to replace any recipient that does not follow through with college admissions in the fall.

Student Qualifications

For a senior to be eligible for The GEO Group, Inc., **Folkston ICE Processing Center** Academic Scholarship, qualified candidates must meet the following requirements:

1. **Be a High School Senior with an acceptance letter from an accredited college or university.**
2. **Have at least a 3.0 Academic GPA.**
3. **Live in the community served by a GEO facility.**

The deadline for applicants to submit the applications will be Friday, May 3, 2024 by 1:30 p.m

1. **The student must be in good standing with the Camden County High School and with the Camden County Board of Education.**
2. **The student must be accepted and enrolled in college for the fall semester following graduation with documentation of enrollment.**
3. **The student must have exhibited outstanding leadership skills through his/her conduct and attitude, academic and extracurricular activities.**
4. **The student must write a paragraph detailing future plans and how this scholarship will help he or she attain those goals.**

This scholarship is strictly an overall merit scholarship and will not be based upon financial need.

Please include your name on the scholarship application. Your name should be on the cover sheet and application.

The deadline for returning the scholarship application is **Friday, May 3, 2024 by 1:30 p.m.** **The application is to be returned to the CCHS school counselor, in a sealed envelope marked The GEO Group, Inc./FIPC Scholarship.** Please adhere to these procedures.
