

PAWS Date November 29	SECOND SEMESTER Loading	PART I Second Semester Schedules Advisors will distribute 2 <sup>nd</sup> Semester course schedules to all advisory students. Students should verify that their schedule does not include any courses they are currently enrolled in or have previously earned high school credit.
		If students wish to make a request to change their intended schedule, they need to complete a Spring 2024 Schedule Change Request Form. Schedule Change Forms can be picked up outside of both Guidance Offices AFTER ADVISORY (NOT DURING ADVISORY!). Students can also print a copy of the Spring 2024 Schedule Change Request Form, which is located on the CCHS Website, PAWS/Advisory website and Advisory Google Classroom. NOTE: Students will only have until January 5 <sup>th</sup> to turn in a schedule change form. Forms will not be accepted after January 5 <sup>th</sup> .

	IMPORTANT: Final Exam Information	PART II Advisors will relay the information below with students about the final exam exemption and testing schedule.



A student will be exempt from a final exam if they meet the following grade and attendance criteria:

90-100 (Max of 5 Absences)

80-89 (Max of 3 Absences)

76-79 (Max of 1 Absence)

70-75 (Max of 0 Absences)

Students who are not eligible by the deadline will be required to take a Final Exam. Students who become ineligible after the deadline and do not take a Final will be required to make the Exam up in January or will have a zero entered in as E2.

- Final Exam Exemption will be based on grades and attendance listed in PowerSchool at the end of the day on 12/7/23. For December graduates, eligibility will be determined based on grades and attendance in PowerSchool at the end of the day on 12/1/23. If a student accrues additional absences and/or if their grade drops below their current exemption standing, the student will lose exemption eligibility. Students in an EOC class, remember that you will have a rigorous assignment that will be required on final exam days for a major grade (unless you are exempt).
- If you are NOT EXEMPT from ALL FINALS, then you must report to school on Thursday 12/14 and Friday 12/15.
- If you are exempt from a single classroom final (<u>but not all classroom finals</u>), then you will report to that class for an exemption pass on the day of testing for that block, then report IMMEDIATELY to the cafeteria for the remainder of the block.
- Finals for yearlong courses will not be administered until May 2024. If you are in a yearlong course, you should still plan to attend class on 12/14 and 12/15, even if you are exempt from finals in other courses.

Note: A student can be eligible to exempt and still take a final for no harm. For example, if a student has a T2 grade of 89, they may want to take a final to improve the grade to an A. If a student is eligible but chooses to take the test, the student receives the higher grade (T1 or E1 Grade) for the final exam grade (E2).
